## **Background**

"Balance in Sport – Tools to implement Gender Equality". The project aims to identify and test generally agreed Gender Equality indicators in sports which will enable a uniform approach to collect relevant data on Gender Equality (GE) and impact on the design of policies to redress persisting inequalities. It will map the *de facto* sports situation, including leadership, coaching, media, participation and violence. During the project tools will be developed to facilitate the implementation and use of these indicators by public authorities in charge of sport and sport organisations.

The project is financed by the European Commission and the Council of Europe and implemented in co-operation with partner organisations and relevant stakeholders.

#### **Objectives of the Balance in Sport workshop**

The workshop is designed in an interactive way engaging participants to exchange information and share their relevant expertise, views and know-how.

Specifically, the workshop aims to:

- fine-tune and conclude the work on the generally agreed GE indicators
- develop with partners ideas on tools/ trainings on the use of GE indicators in sport

A number of stakeholders such as sports organisations, partners and experts will be involved in the project.

#### **Programme elements and methodology**

The programme is organised in an interactive way engaging participants in discussions. It will include presentations by consultants/ experts/ top practitioners.

The event will feature the following:

- High profile speeches on Gender Equality and Gender Equality in sports indicators
- Best practice example(s)
- Working groups on topical issues

- Generally agreed GE indicators in sport
- Concepts of tools to use/ implement GE indicators
- Design of a training to promote the use/ implementation of GE indicators
